Full day school vacation and school closure days:

\$50.00 Daily (this rate applies to individual full days i.e. snow day or teacher workshop.
Regular Tuition rate applies for the remainder of the week)
\$200.00 Weekly

Families are required to pay their full tuition rate regardless of holidays and their child’s attendance in our program.

Multiple Child Rates: *There is a 25% discount for the second child and any additional siblings. The discount is taken on the slot charged at a lower rate. This discount also applies to the school age program both school year and summer.*

POLICIES

Tuition Policy: As a non-profit agency, we rely on your prompt payment for the important services we provide. Payment is expected in advance, on Monday, for the upcoming week of care. We will charge a late payment fee of \$10 for any accounts that are 2 or more weeks over due. If your account is 3 or more weeks in arrears we will not be able to accept your child for care the following Monday.

We do not wish to cause any inconvenience or hardship to families, but are not in a financial position to offer credit for large balances.

Scholarship Assistance: *You may be eligible for reduced rates through the State of New Hampshire Child Care Development Fund Scholarship, please visit the local Dept. of Human Services Office or website.*

Credit Card Payments: *Rochester Child Care Center offers the option of automatic payments made weekly by credit card. Please request our Automatic Credit Card Payment form.*

Vacation Policy: *After 3 months of attendance in our program, **full time** private fee families who have children enrolled at the center are allotted 10 vacation days per year in which a family will not be charged for their child's absence from his/her program. All requests to use these days must be submitted to the office immediately following the absence. All vacation days renew September 1st each year.*

Children enrolled in the School Age "Up" program do not accumulate vacation days.

Return Check Policy: *A \$35.00 charge will be applied for any returned checks. Once we have received two returned checks on an account, cash only payments will be required.*

Late Pickup Charge: *A \$15.00 late charge may be applied to any families who arrive between 6:00pm and 6:15pm. After 6:15 you will be charged \$15.00 for each 15 minute increment.*

Food Program: *Rochester Child Care Center participates in the CACFP Food Program and offers nutritious meals at no additional cost to families. CACFP forms are required in order for us to participate in this program. Forms must be updated yearly.
